### Executive Committee Appointments 2026

Each year a Nominating Committee is approved by Council to compile a slate of nominees for the non-Presidential positions on the Executive Committee where there is an upcoming vacancy, including any vacancy resulting from the expiration of a term of office:

- the three Vice-Presidents,
- the Treasurer,
- the Chairs of the Standing Committees, and
- the Members-at-Large.

In order to compile a slate of candidates, the Nominating Committee solicited and considered recommendations from the incumbent President, the Executive Committee members, and Council.
