## **UTFA Updates: AGM; Part-time Policy; Matthew Shenoda lecture**

November 3, 2020

- 1. Thank you for making **UTFA's AGM last Thursday such an enormous success**! We had more than 250 people in attendance over the course of the event. Attendees made it clear that they wanted to delve further into the featured panel topic, *Creating the University We Want During and After the Pandemic*, and to hear more about Salary, Benefits, and Workload Negotiations with the Administration as they unfold. UTFA is planning to host related events throughout the academic year.
- 2. I'm pleased to announce that the revised **Part-time Policy negotiated between UTFA and the Administration was passed by Governing Council** on October 29th. Some highlights of the new policy include:
  - 1. Effective October 29th, the titles of part-time Teaching Stream faculty with the title of 'Lecturer' have changed to 'Assistant Professor, Teaching Stream' and the titles of part-time Teaching Stream faculty with the title of 'Senior Lecturer' have changed to 'Associate Professor, Teaching Stream'. Titles for part-time faculty with tenure stream titles (Assistant/Associate/Professor) will remain unchanged.
  - 2. Other aspects of the new policy will become effective January 1, 2021.
  - 3. Part-time faculty who reach six years of successive employment and pass a review will receive a continuing appointment.
  - 4. Transitional provisions have been negotiated for part-time faculty with five or more years of employment in the same unit, including prior CLTA (i.e. full-time) employment, normally without a break in service or more than one year.
  - 5. Improved severance pay for part-time faculty with continuing employment who are terminated without cause.
  - 6. Part-time faculty will be eligible for appointment to SGS or to act as Principal Investigator under the same terms as full-time faculty, and to apply for grants provided they are otherwise eligible.
